Report by the State Superintendent of Education

State Superintendent of Education John White highlighted the following in his report to the Board:

- The Board of Regents (BoR) adopted the Dual Enrollment policy discussed at the joint meeting of BoR and BESE on Monday, December 11, 2017.
- A historical overview of the Minimum Foundation Program (MFP) will be presented at the MFP Task Force meeting scheduled for the afternoon of December 12, 2017, as well as discussion concerning a small number of issues that have been raised by individuals in state and local government regarding challenges that are being incurred because of specific costs and potential adjustments that could be made in the formula. Conversations with members of the Legislature and leaders in the administration indicate that the ability of the state to outlay more funds for K-12 education in the formula is in question and there has been no definitive guidance as to what the Governor will include in his executive budget at this challenging time. The Governor's executive budget will be introduced before the next BESE and MFP Task Force meetings so there will be guidance regarding whether or not the Legislature will consider a budget that includes an increase in the MFP. By that time, the final audited counts for October 1 will be available. Birth cohorts have been slowing since the recession; therefore, several kindergarten classes will be smaller than in past years. All of these topics will factor into the MFP Task Force discussions.
