The meeting was called to order at 10:27 a.m. by Board President Jim Garvey, and opened with a prayer by Dr. VerJanis Peoples, Southern University.

Agenda Report by the State Superintendent of Education

Item 5.

State Superintendent of Education White stated that during the month of July schools will receive LEAP, End-Of-Course, ACT, Advanced Placement, International Baccalaureate, and WorkKeys assessment results. In the fall, LDE will discuss those results with district superintendents and school principals. Historically, the LEAP, ACT, Advanced Placement, and graduation results, which lag by one year, are typically the subject of large public discussion, and should be released before the next BESE meeting. State Superintendent White stated that over the last several weeks he has conducted meetings with education, civil rights and advocacy, and business and industry stakeholders regarding the Every Student Succeeds Act (ESSA). In late July and early August, public meetings will be held in communities in every BESE district to discuss the law; layout the decisions that LDE, BESE, and any other governmental body need to make; and discuss in depth what the law requires. The most indepth discussions will likely happen at Special Education Advisory Panel, Superintendents' Advisory Council, Accountability Commission, and BESE meetings, as well as on-going statewide meetings of teacher leaders, superintendents, and others.

 - received the Summary of Public Comments and Agency Response (SPCAR) regarding the establishment of Bulletin 141, *Louisiana Student Standards for English Language Arts*: Chapters 1-23, and the establishment of Bulletin 142, *Louisiana Student Standards for Mathematics*: Chapters 1-25;
 - ratified the submission of the summary report to the Legislative Oversight Committee, per interim authority of the Board President; and
 - 3. directed BESE staff to proceed with the final adoption of the Notices of Intent published in the Louisiana Register on April 20, 2016, regarding Bulletins 141 and 142.
- 6.1.4 On motion of Dr. Boffy, seconded by Mr. Davis, the Board approved the following requests, submitted by the Lafayette Parish School System (LPSS), to waive policy outlined in Bulletin 741, *Louisiana Handbook for School Administrators*:
 - 1. §913. Class Size and Ratios, Part D., regarding the system-wide student classroom teacher ratio in grades K-3, which is a maximum of 20 students to one classroom teacher. LPSS requests the flexibility with this ratio, not to exceed 24 pupils to one teacher and not to exceed the required 20 pupils to one teacher in D-rated schools.
 - 2. §913. Class Size and Ratios, Part B. The student hour metric is the product of the number of students and the hours taught per week. The Lafayette Parish high schools have a seven period day. An average class size of 25 would be required for each teacher to meet the required limit of 750 student contact hours per week. This would necessitate a substantial increase in the number of teachers.
 - 3. §1705. School Libraries/Media Centers, relative to secondary school librarian requirements. LPSS requests placing one librarian per secondary school, regardless of school size, as opposed to the required number of two librarians.

NOTE: Speakers testifying on behalf of LPSS indicated that the request relative to §1705. School Libraries/Media Centers is no longer necessary.
