The Louisiana State Board of Elementary and Secondary Education met in regular session on October 12, 2016, in the Louisiana Purchase Room, located in the Claiborne Building in Baton Rouge, Louisiana. The meeting was called to order at 9:18 a.m. by Board President Jim Garvey, and opened with a prayer by Ms. Debbie Meaux, Louisiana Association of Educators.

State Superintendent of Education White highlighted the following in his report to the Board:

• Performance ratings for last year will be released. For the first time, the state will release a comprehensive report of results for child care centers, Headstart centers, and pre-kindergarten. There will

be a staged release of these results over the course of late October and early November 2016. The report will allow child care centers to see what is happening and how the centers can improve through strong curriculum and professional development choices.

 Last week, the LDE issued a draft framework for the Every Student Succeeds Act (ESSA). ESSA does not call for specific policies, but instead calls for states to have a comprehensive plan for school improvement. As a result, the LDE felt it needed to demonstrate to the public how policies, grants, programs, and supports can fit together into one comprehensive plan. Louisiana is far away from the 2017 development of a final plan and submission of that plan, but the action taken so far does advance the process forward. In a few weeks, State Superintendent of Education White will begin a statewide tour for the purpose of receiving more public comments. The Accountability Commission, Special Education Advisory Panel, Nonpublic School Council, and Early Education Task Force will review the framework and provide input. In early November, the framework will also be brought to the Superintendents' Advisory Council and the Superintendent's Task Force for review and input.

Purpose: The purpose of Believe and Prepare: Early Childhood is to support the development of Early Childhood Ancillary Certificate Programs, and to help lead teachers meet the credential requirements within policy. Through the provision of startup funding and ongoing technical support, Believe and Prepare: Early Childhood funds will elevate and professionalize the child care workforce, expand state availability of high-quality teacher preparation programs, and increase the number of children who have access to a teacher with the knowledge and skills necessary to support early childhood development.

Basis of Allocation: Allocations to teacher preparation programs will reimburse the initial startup costs such as technology, supplies, additional staff, and candidate recruitment.

Purpose: The LDE wants to support children with disabilities and their teachers with its commitment to the research-based concept of improving kindergarten readiness by improving adult/child interactions in early childhood settings. The CLASS observation tool for Toddler and Pre-K classrooms is an integral component of this initiative. Classrooms in publicly funded early childhood programs serve a broad spectrum of at-risk children including those identified with disabilities. Recognizing that the adults in these classrooms face the challenge of meeting the needs of all children in their classes, the LDE has identified a set of coaching supports aligned with the CLASS tool and is prioritizing programs where there are children with identified disabilities to receive them. These coaching supports are intended to directly

assist the adults working with children and to assist programs with building and enhancing capacity to support classroom personnel.

Basis of Allocation: Allocations for Lead Agencies are based on the number of support models used and the number of projected teachers and coaches involved.

Two districts opted out of the pilot due to flooding. Eighty thousand dollars was subtracted from the allocations of Livingston and Terrebonne parishes. One hundred forty thousand dollars was added to the allocations of Iberville, Jefferson Davis, Lafayette, Ouachita, and Red River parishes due to additions to their pilot programs. (-\$80,000+\$140,000) = positive \$60,000 net effect.

Purpose: The Jobs for America's Graduates - Louisiana (JAG - LA) program is a dropout prevention/recovery and workforce preparation program for at-risk youth. JAG – LA seeks to keep at-risk students in school through graduation to obtain a high school diploma or a high school equivalency diploma, and during that time improve the rate of success students achieve in acquiring employability and occupational competencies.

Basis of Allocation: Grant allocations for continuation request was conducted to determine the grant awards for FY 2016-2017. Applications were read and scored according to the established selection criteria and the ability to meet the requirements of the 2015-2016 JAG - LA Grant. Due to rejection of awards, the next applicants are being awarded.

Purpose: School improvement grants directly support and empower Local Education Agencies (LEAs) to pursue high-quality initiatives that will transform educational opportunities for students attending Louisiana's lowest-performing schools.

Recipients of funds submitted competitive grant proposals to the LDE and were evaluated using a rubric by a review committee. Funding determinations were based on applicant score, status of the LEA school transformation efforts, and proposed school improvement model.

The Winn Parish allocation will provide a stipend to a teacher who is helping implement: (1) a low-cost, secure, and scalable Micro-Enterprise Credential exam portal that will provide students with multiple opportunities to pass this IBC exam without additional costs to the high schools/districts; and (2) an easy-to-use credential tracking portal. The teacher earned a Micro-Enterprise Credential during the summer of 2016 and is providing invaluable technical assistance that will make it intuitive for teachers to help students earn a Micro-Enterprise Credential while minimizing costs for LEAs.
