State Superintendent of Education White highlighted the following in his report to the Board:

- There have been positive gains concerning the number of students annually achieving advanced placement credentials. The number has gone up 12% over the last year and 167% since 2012.
- Statewide CLEP results have been announced, and Louisiana is the nation's leader in CLEP awarded credits.
- ESSA approved progress index results will be forthcoming. This will include results concerning students achieving basic, mastery, etc., as well as school wide gains. The Board will be briefed prior to that announcement.

- Policy issues concerning dialogue regarding pathways into school leadership will come in October.
- Bulk of decisions concerning charter school issues will come in December.

Description of Service: The LDE has identified a need for parents and families of students with disabilities to have access to high-quality, understandable, and actionable support and resources as relate to the educational experiences and special education process and programming for their students. The contractor will conduct regional trainings to instruct parents and families of students with disabilities on both the content of the resources and how to effectively use the resources to better understand the Special Education process and programming. As a critical step in the process of creating, refining, and disseminating these materials, the contractor will engage key stakeholders, most notably parents and families of students with disabilities, for interviews and focus groups to continually revise and improve the content of the product.

Purpose: The Louisiana Healthy School Communities project will use the Whole School, Whole Child, Whole Community (WSCC) model as a framework to improve Louisiana students' health and academic achievement through improving statewide school health infrastructure, increasing professional development (PD) and technical assistance (TA) opportunities to support nutrition, physical activity and the

management of chronic conditions in school settings.

Outcomes: The Louisiana Healthy School Communities team expects to achieve the following outcomes as a result of this project: (1) increased skills among individuals trained to improve student health; (2) increased percentage of schools that do not sell less healthy foods and beverages: (3) increased percentage of schools that have established, implemented and/or evaluated a Comprehensive School Physical Activity Program (CSPAP); (4) increased percentage of schools that provide case management for students with chronic health conditions; (5) increased percentage of students who ate vegetables 3 or more times per day; (6) increased percentage of students who ate fruit or drank 100% fruit juices 2 or more times per day; and (7) increased percentage of students participating in 60 minutes of daily PA.

Basis of Allocation: Louisiana Department of Education, Healthy School Communities project will allocate funding to 6 Local Education Agencies (LEAs) and schools will implement evidence-based school health policies, practices and programs that increase opportunities for healthy eating, physical activity and management of chronic health conditions during the school day as well as during out-of-school time. Awarded LEAs will be expected to implement the following strategies and activities using a comprehensive, district approach over the 5-year period of performance. LEAs should work with elementary, middle, and high school levels to implement the following activities:

- 1. Supportive Nutrition Environments: Improve the school nutrition environment (i.e. Smart Snacks in School, access to safe, free drinking water, Smarter Lunchrooms);
- 2. Supportive Environments for PE and Physical Activity: Increase and improve physical education and physical activity through Comprehensive School Physical Activity Programs;
- 3. Management of Chronic Conditions: Support the development and maintenance of a system to manage chronic health conditions;
- 4. Healthy Out-of-School Time: Support the role out-of-school time programs can play in supporting student health and academic achievement;
- 5. Professional Development: Support staff and teachers' attendance in grant related professional development; and

6. Overall School Health: Utilizing the Alliance's Healthy Schools Program, LEAs and schools will work on making improvements, learn from successes and challenges and keep pushing the needle forward.
