The meeting was called to order at 9:23 a.m. by Board President Sandy Holloway and opened with a prayer by Pastor Johnny Green, Healing Place Church.

### Agenda Report by the State Superintendent of Education Item 5.

- Ms. Beth Scioneaux will be Acting State Superintendent as of March 12, 2020. Internal transitions and management structures have been arranged regarding academic, fiscal, policy, and legislative issues. Senior staff is at the ready to communicate as needed.
- Covid-19 has presented unforeseen issues that may prompt certain decisions related to education in the days to come. The Governor has created a task force, and several LDE designees are covering that task force. There is also an internal working group meeting regularly to discuss topics related to this issue. School systems in the areas of the highest rates of infection are closing, and that number of closures is likely to increase. The LDE is monitoring guidance from governmental agencies in order to be an affective aggregator of information and source of reporting.

# Agenda Item 6. Report(s) from members of BESE (Statutory and Legislative Task Force/Council Appointees)

- Dr. Davis, co-chair of the Special Education Advisory Panel (SEAP), reminded members of the next meeting of the panel scheduled for Wednesday, March 25, 2020.
- Ms. Voitier, representing BESE on the Dual Enrollment Task Force, informed members that the task force met on February 19, 2020, and finalized the report that emphasizes equity and access concerning dual enrollment. Dr. Kim Hunter Reed will be presenting the report to the College and Career Readiness Commission at its next meeting. In the Governor's proposed budget, there is five and a half million dollars (\$5,500,000) set aside through higher education for the dual enrollment effort. Two million dollars (\$2,000,000) is set aside for mobile labs, and three and a half million dollars (\$3,500,000) is set aside for potential competitive programs.
- Mr. Morris, representing BESE on the LaSTEM Advisory Council, informed members that at its meeting on Thursday, February 13, 2020, the council approved the release of requests for applications for regional STEM network centers and directors. The deadline for applications is May 29, 2020. The council also proposed alignment to framework of the National STEM Strategic Plan, which will be presented at the next meeting on Wednesday, May 20, 2020.

**Description of Service:** LDE has contracted with SchoolKit to train educators across the state on the content, pedagogy, and programmatic implementation of curricula rated Tier 1 and aligned to state standards for student learning. This amendment would allow for the continued expansion of that work through the development and implementation of cycle 2 of school support institutes, which will support school leadership teams to develop content-specific instructional leadership in their schools.

Initially, LDE's contract with SchoolKit involved the design and delivery of the ELA guidebooks content leaders, a program that, at its completion, will have trained nearly 1,000 educators across the state on Louisiana's ELA/literacy curriculum. In 2019, SchoolKit worked with LDE to launch Intervention Content Leaders, a program designed to similarly train teams of leaders and teachers from schools that struggle with subgroups of students. This program supports these schools to better implement Tier 1 curricula for all students, ensure that teachers are engaged in effective collaborative planning to support students who struggle, and that leaders implement systems and structures to support effective instruction for all students.

Additionally, in 2019, LDE and SchoolKit launched cycle 1 of the School Support Institutes (SSIs), which built on both ELA Guidebooks Content Leaders and Intervention Content Leaders through equipping school leadership teams with the knowledge they need to ensure that at-grade-level, Tier 1 curriculum-aligned instruction is occurring in their schools. SSIs provided these teams with training on the critical activities that leaders must undertake to realize this work, such as high-quality observation and feedback, impactful instructional planning using Tier 1 ELA and math resources, and establishing effective systems and structures in their schools to support rigorous, standards-aligned instruction.

Cycle 1 of SSIs involved three days of training, taking place in the fall of 2019 and winter of 2020. Cycle 2 of SSIs will begin earlier, with two days of training occurring in May 2020 during the Teacher Leader Summit. This adjustment in timeline will allow for school leadership teams to receive some of this training to ensure that what is learned can be implemented in schools for a maximal amount of time.

In order to ensure continued alignment between cycle 2 of SSIs and cycle 1 of SSIs, Intervention Content Leaders, Content Leaders and the state's 2019-2020 and 2020-2021 academic vision and strategy, LDE seeks an amendment of the contract to include the development and delivery of 2 days of training for cycle 2.

LDE staff reviewed applications from eligible applicants and awarded funding to the highest quality plans that demonstrated evidence of sound scientific principles, an environmental focus, and potential for direct positive impact on Louisiana educators and/or students.

### **School and District Support - Other**

**Purpose:** The purpose of the Louisiana School Mental Health Support Program is to develop and implement a multi-tiered system of support model to ensure school-aged youth and their families have access to appropriate mental health services in their school and community through the collaboration of LDE, LDH-OBH, three partner LEAs, and local treatment providers. This will be accomplished through the following:

- 1. increase the educator's awareness and understanding of mental health issues that may be impacting a student's success in the home, school, and community;
- 2. increase the educator's ability to identify students exhibiting potential mental health issues and refer them for screening and possible services:
- 3. increase the number of mental health providers in the targeted schools: and
- 4. connect students with possible mental health issues and their families to needed services in their community.

This supplement is to provide additional funding from carryover funds. The funds will be used to support the continued implementation of grant activities.

Basis of Allocation: The Louisiana Department of Education, Louisiana's School Mental Health Support Program, allocated funding to the three partner local education agencies (LEAs) to conduct activities and provide services that are part of the comprehensive plan to accomplish project goals and objectives. The allocations are based on the funding formula established by the U.S. Department of Health and Human Services' Substance Abuse and Mental Health Services Administration (SAMHSA) Funding Opportunity, Announcement No. SM-18-006, requiring that not less than 60 percent of the annual award may be used by the LEA for project activities and services. The three partner LEAs were selected based on their involvement in the school redesign process and an analysis of data. Each LEA received a base allocation with an additional per-pupil allocation.

Ms. Ellis and Ms. Voitier recused themselves from voting on this item.
