# AgendaReport(s) from members of BESE (Statutory and Legislative TaskItem 5.Force/Council Appointees)

- Dr. Davis updated the Board regarding the recent activity of the Louisiana Educational Television Authority (LETA). In July, Louisiana Public Broadcasting (LPB) will begin daily programming dedicated to education, particularly math. Webinars will also be available to show interested parties how to use the many online resources the Public Broadcasting Service (PBS) has to offer. LETA, LPB, and LDE have had a great partnership helping education continue while children are at home. LPB's use of television programming has been important given the disparity of online access in the state.
- Mr. Morris, member of the Louisiana Environmental Education Commission (LEEC), informed members that the commission is working on developing the state's environmental literacy plan. The plan will coordinate the efforts of formal and non-formal environmental educators that call for a population that understands, feels connected to, and is inspired to protect, preserve, and restore our environment for future use and sustainability.

- 6.1.2 On motion of Mr. Roque, seconded by Dr. Davis, the Board received the summary report of waiver requests, submitted by Local Education Agencies (LEAs) for the 2020-2021 school year, regarding policy contained in Bulletin 741, *Louisiana Handbook for School Administrators*: §2313. Elementary Program of Studies, pertaining to BESE mandated elementary level foreign language programs, as submitted by the Acting State Superintendent of Education.

- 6.1.3 On motion of Dr. Davis, seconded by Mr. Roque, the Board approved the request, submitted by the East Baton Rouge Parish School System (EBRPSS), to waive policy contained in Bulletin 1706, *Regulations for the Implementation of the Children with Exceptionalities Act*: §1904. Definitions *Resource Room*, for the 2020-2021 school year. This approval is contingent upon the following:
  - Criteria for admission to Scholastic Academy should continue to be clearly established and concentrated in the elementary grade levels Pre-Kindergarten through sixth grade. Above sixth grade, the only students who can be recommended for Scholastic Academy are students who move into the parish from other districts, state, countries, or transfer from private or parochial schools;
  - After two years in the Scholastic Academy, students who do not meet state criteria for gifted must be placed in non-blended classes rather than remaining in the Scholastic Academy blended gifted classes for the remainder of school careers. Students will exit the program, if need be, at the end of the school year rather than at mid-term; and
  - EBRPSS must monitor each site that contains a Scholastic Academy blended gifted class for elementary, middle, and high school levels to assure that policies and procedures are consistently followed throughout the district.

For future waivers to be approved, the high percentage of minorities participating in the district's gifted programs must remain the same or continue to increase.

- 6.1.4 On motion of Dr. Davis, seconded by Mr. Roque, the Board approved the request, submitted by the St. Charles Parish School System (SCPSS), to waive policy contained in Bulletin 1706, *Regulations for the Implementation of the Children with Exceptionalities Act.* §1904.   - Participating schools will include: R.K. Smith Middle, Luling Elementary, Cammon Middle School, and St. Rose Elementary;
  - Criteria for admission to the pilot program should be clearly established;
  - Class sizes should be limited to 12 students per setting;
  - Mandatory screenings should be completed after one full year of instruction, not six months;

**Description of Service:** The contractor will provide management of the Child Care Scholarship Program, a key quality support program for child care teachers and leaders. The scholarship program is funded through the Child Care Development Fund (CCDF). Scholarships are awarded only after candidates exhaust other financial aid.

Scholarships are available for:

- early childhood ancillary certificate programs;
- supporting child care teachers to attend a BESE-approved early childhood ancillary certificate program and complete CDA training;
- college tuition;
- supporting child care staff to attend college coursework (either an associate's or bachelor's degree) in an early childhood-related field;

The strategies and activities of this model are evidence-based and data-driven, with the stated purposes of reducing the need for punitive disciplinary measures and increasing the amount of instructional time for students. With these contracts, LDE will fund and facilitate eight regional consortia to provide statewide access to professional development, trainings, and resources.

**Description of Service:** Too many school-aged children with mental health problems are not getting the help needed. When these needs are left unmet, mental health problems are linked to costly negative outcomes such as school failure, suicidality, substance misuse, delinquency, and potential violence in schools. Timely and adequate behavioral health therapy can promote lifelong prosocial behaviors and social emotional development. Conversely, untreated or poorly managed childhood mental health disorders have significant consequences not only for the child and family, but also for a range of systems, including:

- health care;
- child welfare;
- juvenile justice systems; and
- public education.

The purpose of this contract is to expand and strengthen the schoolbased mental health workforce to support multi-tier systems of support (MTSS) in high-need K-12 schools in up to 12 high-need local education authorities (LEAs) in southeast and central Louisiana through a partnership between the Louisiana Department of Education (LDE) and Louisiana State University School of Social Work (LSU SSW).

Recipients of LEEC grants must comply with all terms of the grant and applicable grant guidelines.

- coordinate birth-to-age-five enrollment for publicly-funded programs and the state funding application for the Community Network.

Additionally, a multiplier is applied to the secondary community networks' perclassroom allocations. This will raise the per-classroom allocation rate from \$525.00 to \$787.50 for classrooms located in a secondary community network under the purview of the lead agency. Additionally, the rate of \$787.50 will be applied to classrooms located in school systems in community networks where more than 10 percent of the total classroom count are located in secondary school systems required to complete the Super App.

**Purpose:** The Coronavirus Aid, Relief, & Economic Security (CARES) Act dedicated aid to support K-12 education through the Elementary and Secondary School Emergency Relief Fund (ESSERF). In addition to receiving a formula allocation of ESSER funds, LEAs were eligible to apply for ESSER Incentive grants to support key Strong Start 2020 planning priorities, including curricular materials and PD for continuous learning, post-secondary planning for high school students and recent graduates, supports for students with disabilities, and assistance with developing professional learning and adaptive staffing plans.

**Basis of Allocation:** To be eligible for ESSER Incentive grants, the LEA had to commit to all relevant Strong Start 2020 priorities. An LEA's request for additional funding was considered on a case-by-case basis and accounted for need and alignment with Strong Start 2020 plans.

- increased skills among individuals trained to improve student health;
- increased percentage of schools that do not sell less healthy foods and beverages:
- increased percentage of schools that have established, implemented and/or evaluated a comprehensive school physical activity program (CSPAP);

- increased percentage of students who ate vegetables 3 or more times per day;
- increased percentage of students who ate fruit or drank 100 percent fruit juices 2 or more times per day; and
- increased percentage of students participating in 60 minutes of daily physical activity (PA).
