The Louisiana State Board of Elementary and Secondary Education met in regular session on October 14, 2020, in the Louisiana Purchase Room, located in the Claiborne Building in Baton Rouge, Louisiana. The meeting was called to order at 9:03 a.m. by Board President Sandy Holloway and opened with a prayer by Dr. Craig Carter, Louisiana Association of Educators.

- In the wake of Hurricane Delta, the LDE has been in contact with system leaders. The damage is being assessed, and the LDE will continue to provide recovery guidance and work with the affected districts.
- The transition to virtual instruction has had to happen in a short amount of time, and system leaders and educators have stepped up to the challenge. Guidance in virtual learning best practices has been released to districts for assistance if needed. Survey results showed the biggest platform being used was Google, and

Dr. Chiasson reached out to Google for assistance on behalf of teachers and systems for implementation of this platform. The LDE will be offering Google training, through a webinar series, focused on Google Classroom, Google Screen Share, and Google Notebook. The webinar will be available to teachers and systems at no cost.

- The LDE has partnered with the National Institute for Excellence in Teaching (NIET) on continuing to strengthen practices in virtual instruction and will host a series of professional development focusing on virtual learning models, tips, and strategies that can be implemented.
- ACT has released information for the class of 2020, and the state score has dropped for the third consecutive year. This indicates a need to research what policies and/or practices should be shifted.
- The National Blue Ribbon schools have been named and include Forked Island - E. Broussard Elementary School; Indian Bayou Elementary School; Stephensville Elementary School; Erath High School; Louisiana School for Math, Science, and the Arts; Metairie Academy for Advanced Studies; Catholic High School; Our Lady of the Lake Roman Catholic School; St. Jude the Apostle School; and St. Thomas More Catholic High School.
- October is National Principals month.

# AgendaReport(s) from members of BESE (Statutory and Legislative TaskItem 5.Force/Council Appointees)

 Mr. Roque, a member of the Dyslexia Workgroup, informed members that Act 206 of the 2020 Regular Legislative Session, revised the definition of DYSLEXIA. In response, a workgroup was created to review Bulletin 1903: *Regulations and Guidelines for Implementation of the Louisiana Law for the Education of Dyslexic Students*. Bulletin 1903 was originally promulgated in 1990 and was last updated in 2002. The workgroup is collaborating with various experts and stakeholders to draft revisions to policy that align with state and federal law, as well as the research on dyslexia. Focus areas include requirements for screening to identify students who are at-risk for dyslexia, processes for evaluation and remediation of students with dyslexia, and professional development and training for teachers.

Purpose: The purpose of this program is to support educator development through the use of mentoring. The program provides funds to LEAs and preparation providers to pay stipends to the mentors of undergraduate year-long residents.

Basis of Allocation: Allocations to LEAs and BESE-approved preparation providers are to provide funding for undergraduate mentor stipends.

Through a data collection process, preparation providers and local school systems identified undergraduate residents and their assigned mentors. This includes mentors supporting residents completing a residency from January 2020 through December 2020 and those completing a residency from August 2020 through May 2021.

IDEA funds were allocated at a 100 percent rate if the resident being supported by the mentor is pursuing special education certification. TIF funds were allocated if the residency occurred in a TIF district.

School systems receiving allocations completed a budget request based on the number of teachers and students at each school in addition to system-specific staffing criteria for school-level coaches.

Purpose: The LDE coordinates the Louisiana Early Childhood Care and Education Network by designating, through a competitive process, a Lead Agency for each community to conduct administrative functions and coordinate essential activities.

The Lead Agency also serves as fiscal agent. Lead Agencies must:

- 1. conduct administrative functions for the community network;
- coordinate CLASS observations by assuring that accurate observations are conducted for all Toddler and Pre-K classrooms and that feedback is provided to all participating programs; and
- 3. coordinate birth-to-age-five enrollment for publicly funded programs and the state funding application for the Community Network.

Basis of Allocation: The base funding amount is provided for each lead agency at a rate of \$575 per Infant, Toddler, and Pre-K classroom. The 20 percent increase in allocations is necessary to offset additional costs of carrying out early childhood community network lead agencies responsibilities during the COVID-19 pandemic. The funding source for the additional 20 percent is CCDF.

Purpose: The Louisiana Department of Education (LDE), in partnership with the Louisiana Department of Health (LDH), will coordinate regional Smarter Lunchroom trainings and technical assistance to School Food Service (SFS) professionals to increase selection of healthy foods by children. In addition, LDE and LDH will coordinate culinary skills training series SFS professionals from at least 40 LEAs. In partnership with the Louisiana School Health Training Krewe, LDE and LDH will also continue efforts to provide individualized training and technical assistance on smarter lunchroom practices, school wellness assessment, and best practice in creating healthy school environment to 14 schools and assist the schools in completing the HealthierUS School Challenge: Smarter Lunchrooms applications. The Louisiana State University, Ag program will lead the project evaluation efforts and work to determine project activity reach and implementation and project influence and impact. To help support

local level implementation of the skill and knowledge gained at the regional trainings, LDE and LDH will provide targeted support to 14 schools through a mini-grant process. The mini-grant application was reviewed and scored by a panel of experts in the state. Eligible schools must meet the following criteria:

- 1. schools must be participating in the USDA, NSLP, and SBP;
- 2. schools must designate one representative from the applicant school to attend regional trainings;
- 3. schools must have a team (two or more individuals), wellness council, or School Health Advisory Council willing to implement the mini-grant goals and objectives;
- 4. schools must complete the application by the specified deadline; and
- 5. schools must be committed to creating healthy school environments that support students' healthy eating patterns.

These 14 schools will receive funding and individualized technical assistance from the Louisiana School Health Training Cadre to meet the TNTG goals and objectives. The Louisiana School Health Training Cadre will provide training and technical assistance on incorporating Serving Up MyPlate: A Yummy Curriculum or the SuperTracker Nutrition Lesson Plans for High School Students to the 14 mini-grant recipients. The 14 schools will serve as a model for schools across the state on how to create a healthy school environment that help children have the knowledge, skills, and motivation to make healthy food and physical activity choices as part of a healthy lifestyle. In addition, schools will be able to share successes and lessons learned from providing nutrition education through all six communication channels.

Basis of Allocation: The LDE and Well-Ahead Louisiana will award 14 schools a three-year grant to support healthier school environments that are conducive to healthy eating and physical activity.

Each of the 14 schools will be awarded \$2,500 in 2018-2019 and \$2,800 in 2019-2020 to implement strategies in the schools.
