The Louisiana State Board of Elementary and Secondary Education met in regular session on March 9, 2022, in the Louisiana Purchase Room, located in the Claiborne Building in Baton Rouge, Louisiana. The meeting was called to order at 9:12 a.m. by Board President James Garvey and opened with a prayer by Mr. Walter Brown, Louisiana National Board Network.

For a particular cost to be allowed, it must be an excess cost of providing special education and related services. Costs must exist because of the need for special education and related services, be a child-specific service documented in the student's IEP, and/or be a cost that is not generated by students without disabilities. For a particular cost to be allowed, it must be necessary and reasonable for proper and efficient performance and administration of IDEA Part B 611.

This allocation is increasing the amount of the mentor stipend from \$1,000 to \$1,800 for the 2021-2022 school year.

Purpose: The need to prioritize early literacy is significant. The Coronavirus pandemic has exacerbated existing gaps in early literacy. Families lack access to quality remote learning resources for young children, especially for early literacy instruction. Parents need to understand and be able to support students in remote learning for students to succeed. Real-time Early Access to Literacy (REAL) provides early literacy support for students in pre-K through grade 3. Through REAL, school systems are allocated funding to provide students in pre-K through grade 3 with technology and tutoring services.

This allocation will provide funding for school systems to offer literacy supports/tutoring to pre-K through 3rd grade students. School systems will receive allocations to fund approved tutoring service providers.

Basis of Allocation: Each school system is funded at 10% of its eligible students at \$500 per child. Any remaining children requested during Super App, school systems will receive up to 50% of the eligible student population funded at \$50 per child. If this amount is less than \$10,000, then it will be rounded up to \$10,000.

To support the continuation of the REAL tutoring program during the spring of 2022, an additional 25% of the total 2021-2022 allocation was awarded to each eligible school system that requested additional funds to continue providing tutoring services through the rest of the school year.

Basis of Allocation: On Thursday, March 11, 2021, the American Rescue Plan (ARP) Act was signed into law. It is an unprecedented \$1.9 trillion package of assistance measures, including \$122 billion for the ARP Elementary and Secondary School Emergency Relief (ARP ESSER) Fund.

Funds are provided to state educational agencies (SEA) and local education agencies (LEA) to help safely reopen and sustain the safe operation of schools and address the impact of the coronavirus pandemic on the Nation's students. The SEA allocates funds to the LEAs based on the Title I allocations. These schools did not receive a formula allocation. As such, the department is allocating a portion of their set-aside funds to schools based on requests they submitted.

Part of what drives the lack of access in the state is that many communities lack childcare supply and capacity to develop childcare supply. The purpose of this grant is to provide early childhood community networks with the funding to develop community-level strategies and solutions to increase the supply of, and access to, early childhood care and education.

Basis of Allocation: All early childhood community networks were eligible to apply for this grant opportunity. Recipients were selected based on the quality of their application and status of Ready Start Network activities. Each will receive \$100,000 in allocations, contingent upon final approved application.

Purpose: LDE Division of Nutrition Support was awarded a 2021 USDA Team Nutrition Training Grant. The purpose of the grant is to build state capacity and sustainable infrastructure to develop and standardize recipes for School Meals Programs, with a focus on recipes that incorporate local agricultural products and regional cuisine preferences. LDE proposes to use funds to competitively award mini-grants to eight local school systems that participate in the National School Lunch Program. Sub-grantees will develop two new standardized school meal program recipes for inclusion in the ICN Child Nutrition Recipe Box and provide nutrition education to students.

Basis of Allocation: Grant funds were awarded to school systems via a competitive application process. Eight school systems were chosen for funding based on the submitted mini-grant application, including project idea, school district commitment and budget plan. The state grant team dedicated \$168,000 of the federal award for the purpose of mini-grants; funds were divided evenly (\$21,000 each) among the eight school systems awarded. The grant application included a budget plan and provided written technical assistance regarding allowable and unallowable grant expenses. State agency staff provided additional technical assistance regarding budget to school systems as requested.

Participating networks will assemble a team of high-level partners, community leaders, and stakeholders who will collaborate to develop and implement this vision.

Basis of Allocation: All Ready Start Networks that are currently participating in the 2021 Community Supply Building and Access Expansion (CSBAE) grant. They have consistently and successfully executed all Ready Start Network responsibilities, and displayed the ability to engage a diverse group of stakeholders in a variety of efforts focused on sharing the importance of, and need for, quality early childhood care and education at the local level with the broader community were eligible to apply for this grant opportunity. Recipients were selected based on the quality of their application, strength of proposal, and status of Ready Start Network activities. Each will receive an allocation, ranging between \$250,000 and \$750,000 dependent on the scope of the work presented within the application.

(2) LDH makes it happen (The "LDH Makes it Happen" PCR testing service allows schools to partner with LDH vendors who will provide the end-to-end testing program for the school. LDH will fund the testing program and provide \$14.5k in staff time reimbursements associated with the logistical needs to help coordinate this program).
