Agenda Report by the State Superintendent of Education Item 5.

State Superintendent of Education Brumley highlighted the following in his report to the Board:

- October National School Principal Month;
- Grand awards \$10 million for career opportunities for students with disabilities and over \$55 million from charter school program;
- Release of ACT scores national average dropped 0.3 points, Louisiana increased 0.1 points for the first time in five years; Louisiana is ranked fourth in states that require 100% participation; and
- Early Childhood Summit to be held at the end of May.

Agenda Report(s) from members of BESE (Statutory and Legislative Task Force/Council Appointees)

- Ms. Voitier, representing BESE on the Dual Enrollment Task Force, informed members of the increase in credentialing of teachers to become adjunct professors, the need for an increase in funding for dual enrollment opportunities, and an update to be presented to the BESE/BoR Joint meeting in December 2023.
- Mr. Morris, representing BESE on the LaSTEM Advisory Council, informed members of the LaSTEM Annual Summit to be held October 17, 2023, at the Cajun Dome.
- Mr. Roque, representing BESE on the Nonpublic School Council (NPSC), informed the members of the improvement in collaboration and cooperation as well as progress made regarding certification.
- Dr. Davis, representing BESE on the Special Education Advisory Panel (SEAP), encouraged fellow BESE members to watch videos of previous meeting.
- Dr. Boffy, representing BESE on the Senate Resolution 84 Task Force, informed members of progress within different groups, including the Department of Health, to promote healthy children and ways to provide funding to continue to meet the needs of students.
