In accordance with Section 961 of Title 49 of the Louisiana Revised Statutes, there is hereby submitted a fiscal and economic impact statement on the rule proposed for adoption, repeal or amendment. The proposed change amends LAC 28:CXXXI in *Bulletin 746–Louisiana Standards for State Certification of School Personnel* to expand opportunities for professional advancement in special education by removing the requirement that special education experience be in a “properly certified area” and instead may be in any special education environment.

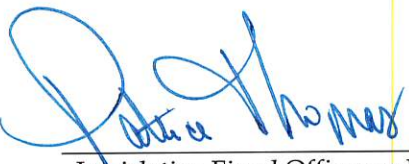
There is no anticipated effect on the revenue collections of state or local governmental units as a result of the proposed rule change.
