SUMMARY

In accordance with Section 953 of Title 49 of the Louisiana Revised Statutes, there is hereby submitted a fiscal and economic impact statement on the rule proposed for adoption, repeal or amendment. Act 334 of the 2021 Regular Session added a course African American History to the eligible courses in the social studies unit for the TOPS core curriculum, beginning with 2021-22 high school graduates.
